What is a practice set?

A practice set is a teaching tool that gives students direct and practical experience in all elements of a manual accounting cycle, and in a very hands-on way.

They will work through activities such as recording transactions into the general journal and special journals of their company and then manually post those transactions into its general ledger and subsidiary ledgers.

At the end of the one month accounting cycle, students construct a trial balance, record adjusting entries, manually prepare the financial statements, and journalise closing entries.

Unique VirtualTutor practice set approach

Perdisco's VirtualTutor manual practice sets are designed to be a similar experience to the paper-based practice set books that many accounting instructors frequently use.
